The undersigned is informed and believes that:

NOTICE: The San Bernardino County District Attorney's Office requests a hearing, and gives notice that the defendant described in this charging document is a threat to the safety of the public, or to the victim(s) of the alleged crime(s) based on the seriousness of the alleged crime(s) and/or the defendant's criminal record, or that the defendant is a flight risk, within the meaning of article I, section 28, subdivision (f)(3) of the California Constitution. Pursuant to rule 4(d) of the California Emergency Rules of Court (April 6, 2020), the People request this Court either deny bail or set bail in an amount consistent with that authorized by Penal Code sections 1269b and 1270.1, subdivision (a)(2), and that the bail consideration follow the requirements of article I, section 28, subdivision (f), and article I, section 12.

COUNT 1

On or about June 5, 2020, in the above named judicial district, the crime of CRUELTY TO CHILD BY ENDANGERING HEALTH, in violation of PENAL CODE SECTION 273a(b), a misdemeanor, was committed by Terry Scott Peterson, who was a person having the care and custody of Jeremiah L, a child, who, under circumstances and conditions other than those likely to produce great bodily injury and death, did willfully cause and permit the person and health of said child to be injured, and did willfully cause and permit said child to be placed in such a situation that its person and health may be endangered.
