COUNT 4

On or about May 31, 2020, in the above named judicial district, the crime of VANDALISM OVER \$400 DAMAGE-DAMAGE/DESTROY, in violation of PENAL CODE SECTION 594(a), a felony, was committed by Terion Alexander Jr, who did unlawfully and maliciously damage and destroy real and personal property, to wit, Windows and interior of business not his/her own, belonging to Der Wienerschntzel, the amount of said damage being over \$400.00.

COUNT 5
