The undersigned is informed and believes that:

COUNT 1

On or about May 1, 2020 through June 22, 2020, in the above named judicial district, the crime of MURDER, in violation of PENAL CODE SECTION 187(a), a felony, was committed by Austin Johns, Anthony Michael Poore and Ciera M Pettaway, who did unlawfully, and with malice aforethought murder Sarah Jacqueline Saranzak, a human being.

"NOTICE as to counts 1 and 2: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c) and a violent felony within the meaning of Penal Code section 667.5(c)."

COUNT 2

On or about May 1, 2020 through June 22, 2020, in the above named judicial district, the crime of TORTURE, in violation of PENAL CODE SECTION 206, a felony, was committed by Austin Johns, Anthony Michael Poore and Ciera M Pettaway, who did unlawfully and with the intent to cause cruel and extreme pain and suffering for the purpose of revenge, extortion, persuasion and for a sadistic purpose, inflict great bodily injury, as defined in Penal Code section 12022.7, upon Sarah Jacqueline Saranzak .
