The undersigned is informed and believes that:

### COUNT 1

On or about August 25, 2020, in the above named judicial district, the crime of ATTEMPTED MURDER, in violation of PENAL CODE SECTION 664/187(a), a felony, was committed by Anthony Thomas Bray, who did unlawfully, and with malice aforethought attempt to murder David Verdugo Jara, a human being.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c) and a violent felony within the meaning of Penal Code section 667.5(c)."

It is further alleged as to count(s) 1 that in the commission of the above offense the said defendant(s) Anthony Thomas Bray, personally inflicted great bodily injury upon David Verdugo Jara, not an accomplice to the above offense, within the meaning of Penal Code Section 12022.7(a) and also causing the above offense to become a serious felony within the meaning of Penal Code Section 102.7(c)(8) and a violent felony within the meaning of Penal Code Section 667.5(c)(8).

"NOTICE: This offense is a serious felony and a violent felony within the meaning of Penal Code sections 1192.7(c)(8) and 667.5(c)(8)."

It is further alleged as to count(s) 1, 2 that in the commission and attempted commission of the above offense the defendant(s) Anthony Thomas Bray, personally used Knife within the meaning of Penal Code section 12022.5(b).

Said act also caused the above offense to become a serious felony pursuant to Penal Code section 1192.7(c)(28) and a violent felony within the meaning of Penal Code section 667.5(c)(8)

It is further alleged as to count(s) 1, 2 that prison custody time for the above offense is to be served in state prison.

#### COUNT 2

On or about August 25, 2020, in the above named judicial district, the crime of CRIMINAL THREATS, in violation of PENAL CODE SECTION 422(a), a felony, was committed by Anthony Thomas Bray, who did willfully and unlawfully threaten to commit a crime which would result in death and great bodily injury to Taylor Wetzel, with the specific intent that the statement be taken as a threat. It is further alleged that the threatened crime, on its face and under the circumstances in which it was made, was so unequivocal, unconditional, immediate and specific as to convey to Taylor Wetzel a gravity of purpose and an immediate prospect of execution. It is further alleged that the said Taylor Wetzel was reasonably in sustained fear of his/her safety and the safety of his/her immediate family.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."

It is further alleged as to count(s) 1, 2 that in the commission and attempted commission of the above offense the defendant(s) Anthony Thomas Bray, personally used Knife within the meaning of Penal Code section 12022.5(b).

Said act also caused the above offense to become a serious felony pursuant to Penal Code section 1192.7(c)(28) and a violent felony within the meaning of Penal Code section 667.5(c)(8)

It is further alleged as to count(s) 1, 2 that prison custody time for the above offense is to be served in state prison.
