The undersigned is informed and believes that:

### COUNT 1

On or about August 26, 2020, in the above named judicial district, the crime of ATTEMPTED WILLFUL, DELIBERATE, AND PREMEDITATED MURDER, in violation of PENAL CODE SECTION 664/187(a), a felony, was committed by Joshua Arturo Vasquez, who did unlawfully and with malice aforethought attempt to murder Mariah Crystal Beach, a human being.

It is further alleged that the aforesaid attempted murder was committed willfully, deliberately and with premeditation within the meaning of Penal Code section 664(a).

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c) and a violent felony within the meaning of Penal Code section 667.5(c)."

<u>It is further alleged as to count(s) 1, 2, 3, 4</u> that in the commission and attempted commission of the above offense, the said defendant(s) Joshua Arturo Vasquez, personally used a deadly and dangerous weapon(s), to wit, Hammer, said use not being an element of the above offense, within the meaning of Penal Code Section 12022(b)(1) and causing the above offense to be a serious felony within the meaning of Penal Code section 1192.7(c)(23).

<u>It is further alleged as to count(s) 1</u> that in the commission of the above offense the said defendant(s) Joshua Arturo Vasquez, personally inflicted great bodily injury upon Mariah Crystal

Beach , not an accomplice to the above offense, within the meaning of Penal Code Section 12022.7(a) and also causing the above offense to become a serious felony within the meaning of Penal Code Section 1192.7(c)(8) and a violent felony within the meaning of Penal Code Section 667.5(c)(8).

"NOTICE: This offense is a serious felony and a violent felony within the meaning of Penal Code sections 1192.7(c)(8) and 667.5(c)(8)."

On or about August 26, 2020, in the above named judicial district, the crime of ATTEMPTED WILLFUL, DELIBERATE, AND PREMEDITATED MURDER, in violation of PENAL CODE SECTION 664/187(a), a felony, was committed by Joshua Arturo Vasquez, who did unlawfully and with malice aforethought attempt to murder Mathew James Gordon, a human being.

It is further alleged that the aforesaid attempted murder was committed willfully, deliberately and with premeditation within the meaning of Penal Code section 664(a).

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c) and a violent felony within the meaning of Penal Code section 667.5(c)."

<u>It is further alleged as to count(s) 1, 2, 3, 4</u> that in the commission and attempted commission of the above offense, the said defendant(s) Joshua Arturo Vasquez, personally used a deadly and dangerous weapon(s), to wit, Hammer, said use not being an element of the above offense, within the meaning of Penal Code Section 12022(b)(1) and causing the above offense to be a serious felony within the meaning of Penal Code section 1192.7(c)(23).

<u>It is further alleged as to count(s) 2</u> that in the commission of the above offense the said defendant(s) Joshua Arturo Vasquez, personally inflicted great bodily injury upon Mathew James Gordon, not an accomplice to the above offense, within the meaning of Penal Code Section 12022.7(a) and also causing the above offense to become a serious felony within the meaning of

Penal Code Section 1192.7(c)(8) and a violent felony within the meaning of Penal Code Section 667.5(c)(8).

"NOTICE: This offense is a serious felony and a violent felony within the meaning of Penal Code sections 1192.7(c)(8) and 667.5(c)(8)."

#### COUNT 3

On or about August 26, 2020, in the above named judicial district, the crime of ATTEMPTED WILLFUL, DELIBERATE, AND PREMEDITATED MURDER, in violation of PENAL CODE SECTION 664/187(a), a felony, was committed by Joshua Arturo Vasquez, who did unlawfully and with malice aforethought attempt to murder Robin Denease Swayzer, a human being.

It is further alleged that the aforesaid attempted murder was committed willfully, deliberately and with premeditation within the meaning of Penal Code section 664(a).

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c) and a violent felony within the meaning of Penal Code section 667.5(c)."

<u>It is further alleged as to count(s) 1, 2, 3, 4</u> that in the commission and attempted commission of the above offense, the said defendant(s) Joshua Arturo Vasquez, personally used a deadly and dangerous weapon(s), to wit, Hammer, said use not being an element of the above offense, within the meaning of Penal Code Section 12022(b)(1) and causing the above offense to be a serious felony within the meaning of Penal Code section 1192.7(c)(23).

<u>It is further alleged as to count(s)</u> 3 that in the commission of the above offense the said defendant(s) Joshua Arturo Vasquez, personally inflicted great bodily injury upon Robin Denease Swayzer, not an accomplice to the above offense, within the meaning of Penal Code Section 12022.7(a) and also causing the above offense to become a serious felony within the meaning of Penal Code Section 1192.7(c)(8) and a violent felony within the meaning of Penal Code Section 667.5(c)(8).

"NOTICE: This offense is a serious felony and a violent felony within the meaning of Penal Code sections 1192.7(c)(8) and 667.5(c)(8)."

# \*\*\*\*\* COUNT 4

On or about August 26, 2020, in the above named judicial district, the crime of AGGRAVATED MAYHEM, in violation of PENAL CODE SECTION 205, a felony, was committed by Joshua Arturo Vasquez, who did unlawfully and under circumstances manifesting extreme indifference to the physical and psychological well being of another, intentionally cause permanent disability and disfigurement and deprivation of a limb, organ and body member of Mariah Crystal Beach.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c) and a violent felony within the meaning of Penal Code section 667.5(c)."

<u>It is further alleged as to count(s) 1, 2, 3, 4</u> that in the commission and attempted commission of the above offense, the said defendant(s) Joshua Arturo Vasquez, personally used a deadly and dangerous weapon(s), to wit, Hammer, said use not being an element of the above offense, within the meaning of Penal Code Section 12022(b)(1) and causing the above offense to be a serious felony within the meaning of Penal Code section 1192.7(c)(23).
