The undersigned is informed and believes that:

COUNT 1

On or about September 4, 2020, in the above named judicial district, the crime of ATTEMPTED MURDER, in violation of PENAL CODE SECTION 664/187(a), a felony, was committed by Ismael Saldivar, who did unlawfully, and with malice aforethought attempt to murder Michael Hall, a human being.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c) and a violent felony within the meaning of Penal Code section 667.5(c)."

It is further alleged as to count(s) 1, 2, 3 that said defendant(s) Ismael Saldivar personally and intentionally discharged a firearm, a handgun, within the meaning of Penal Code section 12022.53(c).

It is further alleged as to count(s) 1, 2, 3, 4, 5 that at the time of the commission of the above offense, the defendant(s) Ismael Saldivar, was released from custody on bail or Own Recognizance in Case Number FWV1303783 within the meaning of Penal Code section 12022.1(b).

COUNT 2

On or about September 4, 2020, in the above named judicial district, the crime of ASSAULT WITH A FIREARM, in violation of PENAL CODE SECTION 245(a)(2), a felony, was committed by Ismael Saldivar, who did willfully and unlawfully commit an assault on Michael Hall with a firearm.

"NOTICE: It is further alleged that, pursuant to Penal Code section 1203.095, there is a presumptive minimal jail time required if you are convicted of this charge."

"NOTICE: Conviction of this offense will require you to provide specimens and samples pursuant to Penal Code section 296. Willful refusal to provide the specimens and samples is a crime."

It is further alleged as to count(s) 1, 2, 3 that said defendant(s) Ismael Saldivar personally and intentionally discharged a firearm, a handgun, within the meaning of Penal Code section 12022.53(c).

It is further alleged as to count(s) 1, 2, 3 that said defendant(s) Ismael Saldivar personally used a firearm, a handgun, within the meaning of Penal Code section 12022.53(b).

It is further alleged as to count(s) 1, 2, 3, 4, 5 that at the time of the commission of the above offense, the defendant(s) Ismael Saldivar, was released from custody on bail or Own Recognizance in Case Number FWV1303783 within the meaning of Penal Code section 12022.1(b).

COUNT 3

On or about September 4, 2020, in the above named judicial district, the crime of ASSAULT UPON PEACE OFFICER OR FIREFIGHTER, in violation of PENAL CODE SECTION 245(c), a felony, was committed by Ismael Saldivar, who did willfully and unlawfully commit an assault with a deadly weapon and instrument and by force likely to produce great bodily injury upon the person of

Michael Hall when said defendant(s) Ismael Saldivar knew and should have known that said person was a peace officer then and there engaged in the performance of his/her duties.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."

It is further alleged as to count(s) 1, 2, 3 that said defendant(s) Ismael Saldivar personally and intentionally discharged a firearm, a handgun, within the meaning of Penal Code section 12022.53(c).

It is further alleged as to count(s) 1, 2, 3 that said defendant(s) Ismael Saldivar personally used a firearm, a handgun, within the meaning of Penal Code section 12022.53(b).

It is further alleged as to count(s) 1, 2, 3, 4, 5 that at the time of the commission of the above offense, the defendant(s) Ismael Saldivar, was released from custody on bail or Own Recognizance in Case Number FWV1303783 within the meaning of Penal Code section 12022.1(b).

COUNT 4

On or about September 4, 2020, in the above named judicial district, the crime of POSSESSION OF FIREARM BY A FELON, in violation of PENAL CODE SECTION 29800(a)(1), a felony, was committed by Ismael Saldivar, who did unlawfully own, purchase, receive, possess, and have custody and control of a firearm, to wit, Handgun, the said defendant(s) having been convicted of a felony under the laws of the United States, the state of California and any other state, government and county:

On or about September 4, 2020, in the above named judicial district, the crime of EVADING AN OFFICER, WILLFUL DISREGARD, in violation of VEHICLE CODE SECTION 2800.2(a), a felony, was committed by Ismael Saldivar, who did willfully and unlawfully, while operating a motor vehicle and with the intent to evade, flee and otherwise attempt to elude a pursuing peace officer's motor vehicle while all of the following conditions existed: the peace officer's motor vehicle exhibited at least one lighted red lamp visible from the front and the defendant(s) saw and reasonably should have seen the lamp, the peace officer's motor vehicle was sounding its siren as was reasonably necessary, the peace officer's motor vehicle was distinctively marked, the peace officer's motor vehicle was operated by a peace officer. It is further alleged that the defendant(s) drove with a willful or wanton disregard for the safety of persons and property.

It is further alleged as to count(s) 1, 2, 3, 4, 5 that at the time of the commission of the above offense, the defendant(s) Ismael Saldivar, was released from custody on bail or Own Recognizance in Case Number FWV1303783 within the meaning of Penal Code section 12022.1(b).
