knowingly possessed or controlled matter, the production of which involved the use of a person under 18 years of age, knowing that the matter depicted a person under 18 years of age personally engaging in or simulating sexual conduct, and the matter contained more than 600 images that violated Penal Code section 311.11(a) including 10 or more images of a prepubescent minor or a minor who was under 12 years of age.
