COUNT 1

On or about December 23, 2018, in the above named judicial district, the crime of CONTACT WITH MINOR FOR SEXUAL OFFENSE, in violation of PENAL CODE SECTION 288.3(a), a felony, was committed by Jason James Bemowski, who did unlawfully contact and communicate with a minor Jane Doe, knowing that Jane Doe was a minor, with the intent to commit an offense specified in Penal Code Section 207, 209, 261, 264.1, 273a, 286, 288, 288.2, 287, 289, 311.1, 311.2, 311.4, and 311.11 involving Jane Doe.
