COUNT 1

It is further alleged as to count(s) 2 that in the commission and attempted commission of the above offense, the said defendant(s) Aaron Michael Munoz, personally used a firearm(s), to wit: revolver, within the meaning of Penal Code sections 1203.06(a)(1) and 12022.5(a) also causing the above offense to become a serious felony pursuant to Penal Code section 1192.7(c)(8) and a violent felony within the meaning of Penal Code section 667.5(c)(8).

COUNT 3

On or about December 9, 2020, in the above named judicial district, the crime of POSSESSION OF FIREARM BY A FELON, in violation of PENAL CODE SECTION 29800(a)(1), a felony, was committed by Aaron Michael Munoz, who did unlawfully own, purchase, receive, possess, and have custody and control of a firearm, to wit, Handgun, the said defendant(s) having been convicted of a felony under the laws of the United States, the state of California and any other state, government and county:

On or about December 9, 2020, in the above named judicial district, the crime of SHOPLIFTING, in violation of PENAL CODE SECTION 459.5, a misdemeanor, was committed by Aaron Michael Munoz, who entered Ulta Beauty, a commercial establishment, with intent to commit

larceny while that establishment was open during regular business hours, where the value of the property that was taken or intended to be taken did not exceed nine hundred fifty dollars (\$950).
