# COUNT 1

On or about January 7, 2021, in the above named judicial district, the crime of CRIMINAL THREATS, in violation of PENAL CODE SECTION 422(a), a felony, was committed by Andrew Robert Downs, who did willfully and unlawfully threaten to commit a crime which would result in death and great bodily injury to Maria Esmeralda Downs, with the specific intent that the statement be taken as a threat.

It is further alleged that the threatened crime, on its face and under the circumstances in which it was made, was so unequivocal, unconditional, immediate and specific as to convey to Maria Esmeralda Downs a gravity of purpose and an immediate prospect of execution.

It is further alleged that the said Maria Esmeralda Downs was reasonably in sustained fear of his/her safety and the safety of his/her immediate family.

# COUNT 2

On or about January 7, 2021, in the above named judicial district, the crime of ASSAULT WITH A DEADLY WEAPON, in violation of PENAL CODE SECTION 245(a)(1), a felony, was

committed by Andrew Robert Downs, who did willfully and unlawfully commit an assault upon Robert Lewis Downs with a deadly weapon, to wit, Other.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."

It is further alleged as to count(s) 2 that in the commission of the above offense the said defendant(s) Andrew Robert Downs, personally inflicted great bodily injury upon Robert Lewis Downs, not an accomplice to the above offense, within the meaning of Penal Code Section 12022.7(a) and also causing the above offense to become a serious felony within the meaning of Penal Code Section 1192.7(c)(8) and a violent felony within the meaning of Penal Code Section 667.5(c)(8).

"NOTICE: This offense is a serious felony and a violent felony within the meaning of Penal Code sections 1192.7(c)(8) and 667.5(c)(8)."
