The undersigned is informed and believes that:

COUNT 1

On or about March 9, 2021, in the above named judicial district, the crime of INJURING A SPOUSE, COHABITANT, FIANCE, BOYFRIEND, GIRLFRIEND OR CHILD'S PARENT, in violation of PENAL CODE SECTION 273.5(a), a felony, was committed by Shawn W Smith, who willfully inflicted corporal injury resulting in a traumatic condition upon Erica Sears , who was someone with whom the defendant had a dating relationship.

It is further alleged that pursuant to Penal Code section 1170(h)(3) defendant(s) Shawn W Smith is eligible for imprisonment in the state prison due to:
