The undersigned is informed and believes that:

# COUNT 1

On or about March 23, 2021, in the above named judicial district, the crime of ATTEMPTED MURDER OF A PEACE OFFICER/FIREFIGHTER/CUSTODIAL OFFICER-WILLFUL, DELIBERATE, PREMEDITATED, in violation of PENAL CODE SECTION 664/187(a), a felony, was committed by Robert Elvis Sparks, who did unlawfully attempt to murder Dustin Whitson , who was a peace officer engaged in the performance of duty and this was known, and reasonably should have been known, by the defendant(s).

It is further alleged, within the meaning of Penal Code Section 664(e) and (f), that the above offense was willful, deliberate and premeditated.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c) and a violent felony within the meaning of Penal Code section 667.5(c)."

It is further alleged as to count(s) 1 that in the commission of the above offense the said defendant(s) Robert Elvis Sparks, personally inflicted great bodily injury upon Dustin Whitson, not an accomplice to the above offense, within the meaning of Penal Code Section 12022.7(a) and also causing the above offense to become a serious felony within the meaning of Penal Code Section 667.5(c)(8).
