The undersigned is informed and believes that:

COUNT 1

On or about January 22, 2021 through April 22, 2021, in the above named judicial district, the crime of PIMPING, in violation of PENAL CODE SECTION 266h(a), a felony, was committed by Lame Donshanell Love, who did unlawfully, and knowing Jane Doe, to be a prostitute, live and derive support and maintenance in whole and in part from the earnings and proceeds of said person's prostitution and from money loaned and advanced to and charged against said prostitute by a keeper, manager, and inmate of a house and other place where prostitution was practiced and allowed and did solicit and receive compensation for soliciting said prostitute.

On or about January 22, 2021 through April 22, 2021, in the above named judicial district, the crime of PANDERING BY PROCURING, in violation of PENAL CODE SECTION 266i(a)(1), a felony, was committed by Lame Donshanell Love, who did unlawfully procure Jane Doe, another person, for the purpose of prostitution.

COUNT 3

On or about April 22, 2021, in the above named judicial district, the crime of POSSESSION OF FIREARM BY A FELON, in violation of PENAL CODE SECTION 29800(a)(1), a felony, was committed by Lame Donshanell Love, who did unlawfully own, purchase, receive, possess, and have custody and control of a firearm, to wit, Handgun, the said defendant(s) having been convicted of a felony under the laws of the United States, the state of California and any other state, government and county:
