The undersigned is informed and believes that:

## COUNT 1

On or about May 1, 2021, in the above named judicial district, the crime of MURDER, in violation of PENAL CODE SECTION 187(a), a felony, was committed by Tyrese Williams Lawrence, who did unlawfully, and with malice aforethought murder Angel M, a human being.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c) and a violent felony within the meaning of Penal Code section 667.5(c)."

It is further alleged as to count(s) 1 that said defendant(s) Tyrese Williams Lawrence personally and intentionally discharged a firearm, a handgun, which proximately caused great bodily injury and death to Angel M within the meaning of Penal Code section 12022.53(d).

It is further alleged pursuant to Penal Code section 186.22(b)(1) and (4) as to count 1, that the above offense was committed for the benefit of, at the direction of, and in association with a criminal street gang with the specific intent to promote, further and assist in criminal conduct by gang members. Said act also caused the above offense to become a serious felony pursuant to Penal Code section 1192.7(c)(28).

"NOTICE: Conviction of this offense will require you to register pursuant to Penal Code Section 186.30(a). Willful failure to register is a crime."

## COUNT 2

On or about May 1, 2021, in the above named judicial district, the crime of SHOOTING AT AN INHABITED DWELLING/OCCUPIED MOTOR VEHICLE/OCCUPIED AIRCRAFT/ETC, in violation of PENAL CODE SECTION 246, a felony, was committed by Tyrese Williams Lawrence, who did willfully, unlawfully, and maliciously discharge a firearm at an inhabited dwelling house.

"NOTICE: It is further alleged that, pursuant to Penal Code section 1203.095, there is a presumptive minimal jail time required if you are convicted of this charge."

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."

It is further alleged pursuant to Penal Code section 186.22(b)(1)(C) as to count 2, that the above offense was committed for the benefit of, at the direction of, and in association with a criminal street gang with the specific intent to promote, further and assist in criminal conduct by gang members. Said act also caused the above offense to become a serious felony pursuant to Penal Code section 1192.7(c)(28).

"NOTICE: Conviction of this offense will require you to register pursuant to Penal Code Section 186.30(a). Willful failure to register is a crime."

## COUNT 3

On or about May 1, 2021, in the above named judicial district, the crime of FIRST DEGREE BURGLARY, PERSON PRESENT, in violation of PENAL CODE SECTION 459, a felony, was committed by Tyrese Williams Lawrence, who did enter an inhabited dwelling house and trailer

coach and inhabited portion of a building occupied by Calvin Martinez, with the intent to commit larceny and any felony.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."

It is further alleged that the above offense is a violation of Penal Code Section 462(a).

It is further alleged that the above offense is a violent felony within the meaning of Penal Code 667.5(c) in that another person, other than an accomplice, was present in the residence during the commission of the above offense.

It is further alleged pursuant to Penal Code section 186.22(b)(1) as to count 3 that the above offense was committed for the benefit of, at the direction of, and in association with a criminal street gang with the specific intent to promote, further and assist in criminal conduct by gang members. Said act also caused the above offense to become a serious felony pursuant to Penal Code section 1192.7(c)(28).

"NOTICE: Conviction of this offense will require you to register pursuant to Penal Code Section 186.30(a). Willful failure to register is a crime."

## COUNT 4

On or about May 1, 2021, in the above named judicial district, the crime of ASSAULT WITH A FIREARM-PERSONAL USE OF FIREARM, in violation of PENAL CODE SECTION 245(a)(2), a felony, was committed by Garyeon Land, who did willfully and unlawfully commit an assault on Calvin Martinez with a firearm.

"NOTICE: It is further alleged that, pursuant to Penal Code section 1203.095, there is a presumptive minimal jail time required if you are convicted of this charge."

"NOTICE: This offense is a serious felony and a violent felony within the meaning of Penal Code sections 1192.7(c)(8) and 667.5(c)(8)."

It is further alleged that the defendant(s) Garyeon Land personally used a firearm, to wit, a Handgun within the meaning of Penal Code sections 12022.5, 1192.7(c) and 667.5(c).

It is further alleged pursuant to Penal Code section 186.22(b)(1) as to count 4 that the above offense was committed for the benefit of, at the direction of, and in association with a criminal street gang with the specific intent to promote, further and assist in criminal conduct by gang members. Said act also caused the above offense to become a serious felony pursuant to Penal Code section 1192.7(c)(28).

"NOTICE: Conviction of this offense will require you to register pursuant to Penal Code Section 186.30(a). Willful failure to register is a crime."

#### COUNT 5

On or about May 1, 2021, in the above named judicial district, the crime of ACCESSORY AFTER THE FACT-(KNOWLEDGE OF CRIME), in violation of PENAL CODE SECTION 32, a felony, was committed by Garyeon Land, who unlawfully, having knowledge that the crime of murder/assault with a firearm, a felony, in violation of Section 187 and/or 245(a)(2) of the Penal Code of the State of California had been committed by Tyrese Lawrence, did harbor, conceal, and aid said Tyrese Lawrence, with the intent that he/she might avoid and escape from arrest, trial, conviction, and punishment for said felony.

It is further alleged pursuant to Penal Code section 186.22(b)(1) as to count 5 that the above offense was committed for the benefit of, at the direction of, and in association with a criminal street gang with the specific intent to promote, further and assist in criminal conduct by gang members. Said act also caused the above offense to become a serious felony pursuant to Penal Code section 1192.7(c)(28).

"NOTICE: Conviction of this offense will require you to register pursuant to Penal Code Section 186.30(a). Willful failure to register is a crime."

## COUNT 6

On or about May 1, 2021, in the above named judicial district, the crime of STREET TERRORISM, in violation of PENAL CODE SECTION 186.22(a), a felony, was committed by Tyrese Williams Lawrence and Garyeon Land, who did unlawfully and actively participate in a criminal street gang with knowledge that its members engage in or have engaged in a pattern of criminal gang activity and did promote, further or assist in felony criminal conduct by gang members.
